Now comes, Rayburn D. Pollard Jr., (claimant no. 464) by and through Pro-Se representation, who objects to the debtors discharge of claimants personal property from the instant Bankruptcy proceeding and respectfully moves this honorable Court to issue an order to Mark Calvert (Trustee) to comply with the wishes of the claimant. The claimant asserts, and the U.S. Supreme Court held, that Pro-Se filings should be liberally construed and held to less stringent standards than those more formal filings drafted by lawyers. *Haines v. Kerner*, 404 U.S. 519-521 (1972)

History

- 1). During tax years, 2009, 2010, 2011, and 2013, the claimant entered good faith commitments with the Debtor to produce four coining die set(s), one each, respectively per year. (see attached exhibits)
- 2). The dies were produced, paid in full, and "archived" at the mint for convenience, to avoid shipping back and forth when orders are required. These dies have been used many times to produce coins exclusively for the Claimant.
- 3). On April 1st 2016 the Debtor filed the instant bankruptcy proceeding, prompting the claimant to file proof of claim #464, to preserve his right to contest.
- 4). Subsequently, the claimant requested, by e-mail, that the Trustee, relinquish possession of his

property and ship to him so he may continue producing his designs at another mint.

5). The trustee asserts that the dies are subject to the instant Bankruptcy action and refuses to ship his dies.

ARGUMENT

The Claimant contends that having paid \$4500.00 (see exhibits 2,4,6,8) for his dies, he owns this res free and clear, he is the rightful owner, and his property is inappropriately deemed subject to the Debtors bankruptcy. The claimant submits that his property is beyond the scope of the instant bankruptcy in so much as it is not the subject of any current or existing order on the books, and that the order was fulfilled long ago, and his dies are simply being stored at the mint.

The invoices attached, clearly and unambiguously stipulate: "Not shipped, archived @ NWTM facility" (see exhibits 1,3,5,7)

The only contact that the claimant has ever had with the debtor, during their seven year relationship, was with their representative, Marty Colwell, from the custom minting dept. Marty Colwell assured him that the mint does not have the authority to use his dies except only at the exclusive behest of the claimant. Therefore, the debtor would be in breach of said agreement and subject themselves to additional civil action if they use them in any other manner.

The claimant contends debtor has not submitted a claim for the dies in question and discharge of the monetary value of third party property is not proper fodder for debtors relief.

This objection is limited to the die(s) portion of his claim and an additional adversarial motion, or complaint, will be executed for the bullion portion of claim 464.

CONCLUSION

WHEREFORE, the claimant prays that this honorable Court deny any and all claims submitted for the amounts that reflect the values of dies owned by third parties archived at the mint, including the claimants own, and issue an order to the Trustee compelling him to comply with the wishes of the claimants in regard to possession of said property, and any such other relief as the Court may deem appropriate..


