RESPONSE TO TRUSTEE'S MOTION TO STRIKE SUPPLEMENTAL MEMORANDUM FILED BY ROSS HANSEN

The Trustee was unavailable for his deposition until July 27 or 28, shortly before Mr. Hansen's response to the Trustee's motion was due. The late date of Mr. Calvert's availability necessitated taking the depositions of the other declarants on July 29. The Trustee's counsel declined to move the hearing beyond August 5 to allow deposition transcripts to become available for Mr. Hansen's response. Rather than trouble the Court with a yet another motion (i.e., to renote the hearing, which Mr. Gearin indicated he would oppose), Mr. Hansen's counsel indicated to counsel and in its brief that Mr. Hansen's response would be supplemented. The Trustee cannot now complain about the submission of his deposition transcript and that of the other declarants.

The Court should deny the motion to strike. In the alternative, if the Trustee wants time to respond to explain the deposition testimony of Mr. Calvert and other witnesses, Mr. Hansen has no objection to moving the hearing date.
